## EXHIBIT A LEGAL DESCRIPTION PERMANENT 20' SEWER EASEMENT

THENCE along said curve to the left through a central angle of 9°42'09", an arc length of 102.45 feet to the common corner of said Lot 4 and said Lot 3.

THENCE S 44°07'04" E, departing said south right of way line of Oak Crest Drive E., along the common line of said Lot 4 and Lot 3, a distance of 791.76 feet to a 5/8 iron rod set with plastic cap stamped "DEOTTE RPLS 4673" at the most southerly corner of Permanent Utility Easement to the City of Fort Worth, recorded in Instrument Number D197015509 of the Deed Records of Tarrant County, Texas (D.R.T.C.T.) also being the POINT OF BEGINNING.

THENCE N 47°00'42" E, along the southeasterly line of said Permanent Utility Easement, a distance of 200.04 feet to a 5/8 iron rod set with plastic cap stamped "DEOTTE RPLS 4673" in the common line of Lot 4 and Lot 5 in said Block 10.




