DESIGNATING ASSISTANT CITY MANAGER DANA BURGHDOFF
TO SERVE AS AN ADVISORY DIRECTOR OF THE BOARD OF DIRECTORS
OF THE BOTANICAL RESEARCH INSTITUTE OF TEXAS, INC.,
A TEXAS NON-PROFIT CORPORATION, AND DESIGNATING PARK AND
RECREATION DEPARTMENT DIRECTOR DAVE LEWIS TO SERVE AS AN
ADVISORY DIRECTOR OF THE BOARD OF DIRECTORS OF BRIT
LANDOWNER, A TEXAS NON-PROFIT CORPORATION

WHEREAS, the Botanical Research Institute of Texas, Inc. ("BRIT") is a privately-created Texas non-profit corporation organized for the purpose of, among other things, protecting, utilizing, expanding, enhancing, and caring for certain botanical collections for the benefit of scholarly research and general public education; and

WHEREAS, the City of Fort Worth ("City") and BRIT are currently parties to the following two agreements: (1) a lease governing the development, construction, and operation of BRIT's public botanical research institute located on City-owned property at 1700 University Drive (City Secretary Contract Number 31471); and (2) a management agreement for operating and improving the Fort Worth Botanic Garden on City-owned property located at 1800 University Drive (City Secretary Contract Number 54201); and

WHEREAS, BRIT Landowner ("Landowner"), a Texas non-profit corporation, was created as a support organization of BRIT; and

WHEREAS, the City's Ethics Code permits a person to serve on the board of directors or other governing board of a business entity without it constituting a substantial interest in the entity so long as the person has been designated by the City Council to serve on such board, the person receives no direct or indirect remuneration for his or her service, and the primary nature of the business is charitable, nonprofit, or governmental; and

WHEREAS, the City Council, as the appropriate body for designating individuals to serve on behalf of the City on the Boards of Directors of BRIT and of Landowner, previously appointed Assistant City Manager Jesica McEachern to serve as an Advisory Director on the Board of Directors of BRIT (Resolution Number 5797-09-2023) and appointed former Director of the Park and Recreation Department Richard Zavala to serve as an Advisory Director on the Board of Directors of Landowner (Resolution Number 5111-06-2019); and

WHEREAS, the City Council now desires to appoint Dana Burghdoff and Dave

Lewis as replacement members to these Boards of Directors; and

WHEREAS, neither Dana Burghdoff nor Dave Lewis will receive any remuneration or have any other financial interests in either BRIT or Landowner;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT WORTH, TEXAS, THAT:

- 1. The City Council designates Assistant City Manager Dana Burghdoff to replace Jesica McEachern as a non-voting Advisory Director on the Board of Directors of BRIT, said designation to remain in effect until City Council designates a successor or until such time as Dana Burghdoff is no longer serving as Assistant City Manager or in a comparable role within the City Manager's Office, whichever comes first.
- 2. The City Council reserves the right, at any time and for any reason, to remove Dana Burghdoff as an Advisory Director on the Board of Directors of BRIT.
- 3. The City Council designates Park and Recreation Department Director Dave Lewis to replace Richard Zavala as a non-voting Advisory Director on the Board of Directors of Landowner, said designation to remain in effect until City Council designates a successor or until such time as Dave Lewis is no longer serving as the Park and Recreation Department Director, whichever comes first.
- 4. The City Council reserves the right, at any time and for any reason, to remove Dave Lewis as an Advisory Director on the Board of Directors of Landowner.
- 5. This Resolution shall take effect immediately upon its adoption.
