SUBJECT

RECOMMENDATION:

It is recommended that the City Council authorize the execution of a contract with Makou Inc., in the amount of \$862,484.00 for 2020 Concrete Restoration Contract 1 at Various Locations.

DISCUSSION:

In the Fiscal Year 2020 Pay-Go Contract Street Maintenance Program, various types of street maintenance are grouped into specific contract packages. The 2020 Concrete Restoration Contract 1 provides for the repair and reconstruction of failed concrete pavement at various locations. (City Project No. 102105).
