(CD 7) Adopt Appropriation Ordinance in the Amount of \$500,000.00 to Provide Funding for the Purpose of Providing Project Management for the Bonds Ranch Road West Segment 1 Project from Boat Club Road to Business Highway 287 and Amend the Fiscal Years 2025-2029 Capital Improvement Program

RECOMMENDATION:

It is recommended that the City Council:

- 1. Adopt the attached appropriation ordinance increasing estimated receipts and appropriations in the Developer Contribution Fund in the amount of \$500,000.00 from available Escrow Account within Unspecified All Funds project (City Project No. UNSPEC), for the purpose of funding the Bonds Ranch Road West Segment 1 project from Boat Club Road to Business Highway 287 (City Project No. 106101); and
- 2. Amend the Fiscal Years 2025-2029 Capital Improvement Program.

DISCUSSION:

On July 17, 2023, HPC Wellington Nance Development Corporation entered into a Future Improvement Agreement in the amount of \$2,999,015.98 (City Secretary No. 59786) with the City to provide funding for its share of the cost of the Bonds Ranch Road West Segment 1 project, as part of the City requirements of its adjacent project.

The purpose of this Mayor & Council Communication (M&C) is to appropriate the Future Improvement Agreement funding for the Bonds Ranch Road West Segment 1 project. The appropriation of these funds will go toward funding project management costs to coordinate the project with the design engineer, the North Central Texas Council of Governments, Texas Department of Transportation, and Tarrant County. The funding will also include City staff costs for internal project management.

Funding for project management costs is budgeted in the Developer Contribution Fund within Unspecified – All Funds project (City Project No. UNSPEC) for the Transportation & Public Works Department for the purpose of funding the Bonds Ranch Road West Segment 1 project.
