AN ORDINANCE ADJUSTING ESTIMATED RECEIPTS AND APPROPRIATIONS IN THE 2007 CRITICAL CAPITAL PROJECTS FUND, BY DECREASING ESTIMATED RECEIPTS AND APPROPRIATIONS IN THE FOLLOWING FORT WORTH PUBLIC ART PROJECTS: (1) BONNIE BRAE (CITY PROJECT NO. 100198) BY \$160,685.96, (2) ALTAMESA (CITY PROJECT NO. 100945) BY \$358,545.40; AND (3) STOP SIX, STALCUP & RAMEY (CITY PROJECT NO. C02114) BY \$166,186.53 AND BY INCREASING ESTIMATED RECEIPTS AND APPROPRIATIONS IN THE 2021 CONCRETE RESTORATION CONTRACT PROJECT (CITY PROJECT NO. 102882) BY THE SAME AMOUNT OF \$685,417.89, PROVIDING FOR A SEVERABILITY CLAUSE; MAKING THIS ORDINANCE CUMULATIVE OF PRIOR ORDINANCES; REPEALING ALL ORDINANCES IN CONFLICT HEREWITH; AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FORT WORTH, TEXAS:

SECTION 1.

That in addition to those amounts allocated to the various City departments for Fiscal Year 2022-2023 in the Budget of the City Manager, there shall also be adjusted estimated receipts and appropriations in the 2007 Critical Capital Projects Fund by decreasing estimated receipts and appropriations in the following Fort Worth Public Art projects (1) Bonnie Brae (City Project No. 100198) by \$160,685.96, (2) Altamesa (City Project No. 100945) by \$358,545.40, and (3) Stop Six, Stalcup & Ramey (City Project No. C02114) by \$166,186.53, and increasing estimated receipts and appropriations in the 2021 Concrete Restoration Contract project (City Project No. 102882) by the same total amount of \$685,417.89.

That this ordinance shall be cumulative of Ordinance 25773-09-2022 and all other ordinances and appropriations amending the same except in those instances where the provisions of this ordinance are in direct conflict with such other ordinances and appropriations, in which instance said conflicting provisions of said prior ordinances and appropriations are hereby expressly repealed.

SECTION 4.

This ordinance shall take effect upon adoption.
