


SUBJECT: April 2020 Transportation and Public Works (TPW) Request For Qualifications (RFQ) for Professional Engineering Design and Consultant Services, for Delivery of Planning, Design, and Construction of Capital Projects; Evaluation Process for TPW Professional Service Provider Selection; Identification of Pre-Qualified Professional Services Providers for the 20 Categories contained within the RFQ

This memo is written to identify the pre-qualified Professional Services Providers in each of the 20 categories listed in the April 2020 TPW RFQ for Professional Engineering Design and Consultant Services, for the Delivery of Planning, Design, and Construction of Capital Projects.

The objective of the RFQ was to identify the most competent and qualified firms from which the City may negotiate contracts for professional design services that will be necessary to complete various TPW Capital Delivery Division (CDD) projects. The pre-qualified Professional Services Providers will be considered a pool of the most qualified design firms from which contracts may be negotiated relating to TPW CDD projects arising over the applicable time period. The list was assembled to ensure that the City has the ability to quickly negotiate contracts with competent and qualified firms in an efficient manner.

Evaluation Process:

An evaluation team of three (3) City staff subject matter experts, led by a category captain, was created for each RFQ category to evaluate the Statements of Qualifications (SOQ) submitted for the category. The evaluation team was comprised of City staff from the Capital Delivery, Transportation Management and Regional Mobility Divisions of TPW. In addition, the SOQs and the Pre-Qualified Professional Services Providers lists were evaluated by the City's Business Equity (BE) staff.

Each member of the evaluation team was provided with access to the RFQ, the 3 Addenda and all SOQs. Team members first independently reviewed and scored each SOQ submitted for a given category utilizing the evaluation criteria point values as described in the April 2020 RFQ and the three (3) Addenda. Then the category evaluation team met to review and discuss each SOQ and the scores provided to generate a team score.

Following this process, a second meeting was held at which the team scores for each category were presented by the category captain to TPW and BE Assistant Directors and Directors for concurrence.

A third meeting was then held with TPW and BE leadership to review the *Pre-qualified TPW CDD Professional Services Provider List* for all 20 of the RFQ categories based on the category team recommendations and Business Equity considerations.

Lastly, Business Equity staff independently reviewed and analyzed the SOQ submission for the RFQ, the *Pre-qualified TPW CDD Professional Services Provider List* for all 20 of the RFQ categories. The result of which was agreement with the review and selection of all proposers.

Identification of Pre-Qualified Professional Services Providers:
