Drive

RECOMMENDATION:

It is recommended that the City Council authorize execution of a contract with Makou Inc., in the amount of \$1,449,450.00 for concrete panel replacements at Meadowbrook Drive from Watson Street to East Loop 820 for the 2023 Concrete Restoration Contract 2 project (City Project No. 104179).

DISCUSSION:

The Fiscal Year 2023 Pay-Go Contract Street Maintenance Program, groups various types of street maintenance into specific contract packages. The 2023 Concrete Restoration Contract 2 provides the repair and reconstruction of approximately 10,500 square yards of failed concrete pavement at various street sections on Meadowbrook Dr listed below:
