SUBJECT

(CD 4 and CD 8) Authorize Execution of a Contract with Texas Materials Group, Inc., dba Texas Bit in the Amount of \$1,463,619.35 for 2021 Riverside Drive Resurfacing Project

RECOMMENDATION:

It is recommended that the City Council authorize execution of a contract with Texas Materials Group, Inc., dba Texas Bit in the amount of \$1,463,619.35 for 2021 Riverside Drive Resurfacing Project (City Project No. 102878) on approximately eight and one-half lane miles of street segments.

DISCUSSION:

In the Fiscal Year 2021 Pay-Go Contract Street Maintenance Program, various types of street maintenance are grouped into specific contract packages. The recommended construction contract outlined in this Mayor and Council Communication (M&C) will provide street rehabilitation for approximately eight and one-half lane miles of street segments of Riverside Drive from East Avenue to East Belknap Street under the Contract Street Maintenance Program (City Project No. 102878).

Construction for this project is expected to start in early 2021 and to be completed by summer 2021. Upon completion of the project there will be no anticipated impact on the General Fund operating budget.

This project was advertised for bid on October 8, 2020, and October 15, 2020, in the *Fort Worth Star-Telegram*. On November 5, 2020, the following bids were received:
