In follow up to our phone call this afternoon regarding FW PARD request for an additional 30-day pricing extension. The Texas Parks and Wildlife agreement process was unfortunately extended to correct earlier language inconsistencies that were only discovered during the current approval process. Even though this issue has now been fully resolved, this delay caused us to miss the March 25 Mayor and Council as previously expected. Based on the progress of the Mayor & Council approval documents we are fairly confident the project will hit the 4/22 Mayor Council meeting that will flow into the below timeline for mobilization.
