CANVASSING THE RETURNS; DECLARING THE RESULTS OF THE GENERAL ELECTION HELD ON MAY 3, 2025, FOR THE PURPOSE OF ELECTING A MAYOR AND CITY COUNCIL MEMBERS FOR THE CITY OF FORT WORTH; AND DECLARING A RUN-OFF ELECTION FOR JUNE 7, 2025

**WHEREAS,** on January 28, 2025, the City Council adopted Ordinance No. 27440-01-2025, calling for and ordering a general election to be held on Saturday, May 3, 2025, at which election all qualified voters of the City of Fort Worth would have the opportunity to vote for the purpose of electing a Mayor at large and ten (10) City Council Members from their respective districts; and

**WHEREAS,** on May 3, 2025, the general election was held at which the qualified voters of the City had the opportunity to vote for the purpose of electing a Mayor at large and ten (10) City Council Members from their respective districts; and

**WHEREAS**, pursuant to Chapter 67 of the Texas Election Code, the City Council of the City of Fort Worth is required to canvass the returns and declare the results of the election;

# NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT WORTH THAT:

**SECTION 1.** The declarations and findings contained in the preamble of this Resolution are hereby found to be true and correct and shall be made a part hereof.

**SECTION 2.** The City Council hereby finds and declares that the City Council election for a Mayor and Districts 2, 3, 4, 5, 6, 7, 8, 9, 10, and 11 was held on May 3, 2025, at which election qualified voters were given the opportunity to vote for the purpose of electing a Mayor at large and City Council Members from their respective districts.
