

Ordinance No. _____

AN ORDINANCE RATIFYING THE FOLLOWING CURRENT APPROPRIATIONS TOTALING \$6,898,996.50 ASSOCIATED WITH THE AMERICAN AIRLINES ENHANCED COMMUNITY FACILITIES PROJECT IN THE TRANSPORTATION IMPACT FEE CAPITAL LEGACY FUND IN AN AMOUNT OF \$836,543.49, THE TRANSPORTATION IMPACT FEE CAPITAL FUND IN THE AMOUNT OF \$379,665.01, THE 2007 CRITICAL CAPITAL PROJECTS FUND IN AN AMOUNT OF \$725,000.00, THE 2014 BOND PROGRAM FUND IN AN AMOUNT OF \$787,297.00, AND THE GRANTS CAPITAL PROJECT STATE FUND IN AN AMOUNT OF \$4,170,491.00; PROVIDING FOR A SEVERABILITY CLAUSE; MAKING THIS ORDINANCE CUMULATIVE OF PRIOR ORDINANCES; REPEALING ALL ORDINANCES IN CONFLICT HERewith; AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FORT WORTH, TEXAS:

SECTION 1.

That in addition to those amounts allocated to the various City departments for Fiscal Year 2024-2025 in the Budget of the City Manager, there shall also be ratified the following current appropriations totaling \$6,898,996.50 associated with the American Airlines Enhanced Community Facilities project in the Transportation Impact Fee Capital Legacy Fund in an amount of \$836,543.49, the Transportation Impact Fee Capital Fund in the amount of \$379,665.01, the 2007 Critical Capital Projects Fund in an amount of \$725,000.00, the 2014 Bond Program Fund in an amount of \$787,297.00, and the Grants Capital Project State Fund in an amount of \$4,170,491.00.

SECTION 3.

That this ordinance shall be cumulative of Ordinance 27107-09-2024 and all other ordinances and appropriations amending the same except in those instances where the provisions of this ordinance are in direct conflict with such other ordinances and appropriations, in which instance said conflicting provisions of said prior ordinances and appropriations are hereby expressly repealed.

SECTION 4.

This ordinance shall take effect upon adoption.
