A RESOLUTION DETERMINING THE NECESSITY FOR ACQUIRING REAL PROPERTY AND AUTHORIZING ITS APPROPRIATION OR CONDEMNATION FOR PUBLIC USE

WHEREAS, the Fort Worth City Council on January 23rd, 2024, in M&C _______, ordered and decreed that a public necessity existed to acquire 0.010 acres of land in permanent sanitary sewer easements, from real property located at 7309 Davenport Avenue in the Ridglea West Addition, an Addition to the City of Fort Worth, Block 12, Lot 9, Tarrant County, Texas, as described in the exhibits attached to the above-referenced M&C; those exhibits are incorporated herein for all purposes (the "Property");

WHEREAS, the Fort Worth City Council has determined that:

- the Property is needed for Sanitary Sewer Rehabilitation Contract 107 project (the "Project");
- the land rights in the Property are needed for new the construction, operation, maintenance, replacement, upgrade and repair of the permanent sewer line facility;
- public necessity required the acquisition by condemnation of the Property, located within the alignment of the Project;
- the use of the Property will be a public use; and
- the Real Estate Division of the Property Management Department is authorized to acquire by negotiation the Property needed for the Project.

WHEREAS, negotiations between the City of Fort Worth and the property owner, Judy Butts, were unsuccessful due the inability to negotiate agreeable terms for the property interest being acquired by the City of Fort Worth; and
