AN ORDINANCE DECREASING APPROPRIATIONS IN CERTAIN IDENTIFIED PUBLIC ART PROJECTS IN THE SPECIALLY FUNDED PROJECTS FUND BY A TOTAL OF \$168,000.00 AND INCREASING APPROPRIATIONS IN OTHER IDENTIFIED PUBLIC ART PROJECTS IN THE FUND BY THE SAME CUMULATIVE AMOUNT TO REFLECT CANCELLATION OF PROJECTS AND REALLOCATION OF FUNDS; PROVIDING FOR A SEVERABILITY CLAUSE; MAKING THIS ORDINANCE CUMULATIVE OF PRIOR ORDINANCES; REPEALING ALL ORDINANCES IN CONFLICT HEREWITH; AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FORT WORTH, TEXAS:

SECTION 1.

That the budget of the City of Fort Worth for Fiscal Year 2019-2020, as enacted by Ordinance 23835-09-2019, as amended, is hereby further amended to reallocate a total of \$168,000.00 among Public Art projects within the Specially Funded Projects Fund by reducing appropriations in certain identified projects, which are being cancelled, and increasing appropriations in other identified Public Art projects as follows:

| Water Department Public Art Master Plan (Citywide) | Hemphill-Lamar Connector (CD 9) | \$50,000 |
| I-30 Bridge at Walsh Ranch, design only (CD 3) | Hemphill-Lamar Connector (CD 9) | \$8,000 |
| Berry Street Underpass (CD 9) | Hemphill-Lamar Connector (CD 9) | \$60,000 |

SECTION 2.

That should any portion, section or part of a section of this ordinance be declared invalid, inoperative or void for any reason by a court of competent jurisdiction, such decision, opinion or judgment shall in no way impair the remaining portions, sections, or parts of sections of this ordinance, which said remaining provisions shall be and remain in full force and effect.

SECTION 3.

That this ordinance shall be cumulative of Ordinance No. 23835-09-2019 and all other ordinances and appropriations amending the same except in those instances where the provisions of this ordinance are in direct conflict with such other ordinances and appropriations, in which instance said conflicting provisions of said prior ordinances and appropriations are hereby expressly repealed.

SECTION 4.

This ordinance shall take effect upon adoption.
