SUBJECT

RECOMMENDATION:

1. Declare that negotiations between the City and the property owner to acquire a fee simple interest in approximately 9.406 acres from real property owned by NRCT Diamond, Hill, LLC. Situated in Lot 1, Block 1, Diamond Hill Townhomes Addition, part of the South Gilmore Survey, Abstract No. 580, Tarrant County, Texas, for the Lebow Channel Mitigation Project (City Project No. 103061) were unsuccessful due to the inability to negotiate agreeable terms for the property interests being acquired by the City;
2. Declare the necessity to acquire the described property interest for the Lebow Channel Mitigation Project (City Project No. 103061);
3. Adopt the attached resolution authorizing the City to use its power of eminent domain to acquire the property for public use;
4. Authorize the City Attorney to institute condemnation by eminent domain proceedings to acquire the described property interest from the property owner;
5. Authorize a payment pursuant to an award of commissioners or a negotiated settlement;
6. Authorize the City Manager or his designee to accept and record the appropriate instruments

Upon approval, a condemnation action will be brought and a Special Commissioner's hearing held to acquire the fee simple interest.

"I move that the Fort Worth City Council adopt the resolution authorizing use of the power of eminent domain to acquire a fee simple interest in approximately 9.406 acres from real property owned by NRCT Diamon Hill, LLC. The property is needed to construct the Lebow Channel Mitigation Project (City Project No. 103061) for channel and culvert improvements at NE 36th Street in connection with the Upper Lebow flood mitigation improvements. The property is located at 3601 Deen Road, Fort Worth, Tarrant County, Texas 76106 and Being Part of Lot 1, Block 1, Diamond Hill Townhomes Addition, Part of the S. Gilmore Survey, Abstract No. 580, Tarrant County, Texas. The property interest to be acquired is described by metes and bounds and depicted by survey exhibits attached to this Mayor and Council Communication."

Funding is budgeted in the Stormwater Capital Projects Fund for the purpose of funding the Lebow Channel Flood Mitigation project, as appropriated.

This property is located in COUNCIL DISTRICT 2.
