THENCE northerly, 141.31 feet along a non tangent curve to the right, having a radius of 160.54 feet, a central angle of 50°25'58" and a chord bearing N21°25'38"E, 136.79 feet to a point:

THENCE S43°21'24"E, a distance of 16.00 feet to a point;

THENCE southerly, 127.65 feet along a non tangent curve to the left, having a radius of 144.54 feet, a central angle of 50°35'57" and a chord bearing S21°20'38"W, 123.54 feet to a point;

THENCE southerly, 80.01 feet along a non tangent curve to the right, having a radius of 6,789.08 feet, a central angle of 00°40'31" and a chord bearing S00°21'52"E, 80.01 feet to a point;

THENCE southerly, 7.48 feet along a non tangent curve to the left, having a radius of 657.03 feet, a central angle of 00°39'08" and a chord bearing S02°39'29"W, 7.48 feet to a point lying in said north line;


THENCE S64°59'21"W, along said north line, a distance of 17.96 feet to the point of beginning, containing 0.083 acres of land.
