**SUBJECT**

(CD 3 and CD 9) Authorize the Temporary Closure of Segments of Country Club Circle, Mockingbird Lane, Mockingbird Court, West Cantey Street, Rogers Road, Colonial Parkway, Simondale Drive, Park Hill Drive, Boyd Avenue, Stadium Drive, Highview Terrace, Manchester Street, Walsh Court, Hartwood Drive, Kingston Court, Ann Arbor Court, and Lynncrest Drive and Authorize the Temporary Conversion of Colonial Parkway from Rogers Road to Country Club Circle to One-Way Operation from May 19, 2025 to May 25, 2025 and Rogers Avenue from Avondale Avenue to Colonial Parkway to One-Way Operation from May 13, 2025 to May 27, 2025 to Accommodate the 2025 Charles Schwab Challenge Golf Tournament at Colonial Country Club

It is recommended that the City Council authorize the temporary closure of the following streets segments of Country Club Circle, Mockingbird Lane, Mockingbird Court, West Cantey Street, Rogers Road, Colonial Parkway, Simondale Drive, Park Hill Drive, Boyd Avenue, Stadium Drive, Highview Terrance, Manchester Street, Walsh Court, Hartwood Drive, Kingston Court, Ann Arbor Court, and Lynncrest Drive and authorize the temporary conversion of Colonial Parkway from Rogers Road to Country Club Circle to one-way operation from May 19, 2025 to May 25, 2025 and Rogers Avenue from Avondale Avenue to Colonial Parkway to one-way operation from May 13, 2025 to May 27, 2025 to accommodate the 2025 Charles Schwab Challenge Golf Tournament at Colonial Country Club.

The purpose of this Mayor and Council Communication (M&C) is to approve Colonial Country Club's request for street closures and operational modifications around the venue for the 2025 Charles Schwab Challenge Golf Tournament. Street closures will reduce the amount of non-resident traffic in the adjacent neighborhoods, improve access for emergency vehicles, and ensure the safety of the participants and spectators for the annual Charles Schwab Challenge Golf Tournament. Access will be available at all times to local residents and businesses.

3900 Block of Lynncrest Drive

One-way-conversion for Colonial Parkway from Rogers Road to Country Club Circle from May 19, 2025 to May 25, 2025 as follows: all traffic flow

Additionally, one-way, southbound only, operation of Rogers Avenue from Colonial Parkway to Avondale Avenue from May 13, 2025 to May 27, 2025.

The affected neighborhood association supports the street closures. A traffic control plan and detour route has been approved. Detour signs and message boards will be strategically placed to inform the public. The Department of Transportation and Public Works, Transportation Management Division, has reviewed and concurs with the request.

A Form 1295 is not required because: This M&C does not request approval of a contract with a business entity.
