How did you determine that the item or service is only available from one source? The Police Department Forensics Analysis Laboratory (Crime Lab) currently owns six Agilent Technologies Gas Chromatography Mass Spectrometers (GCMS) configured for Police for the analysis of unknown substances to confirm the identity of street drugs confiscated by patrol officers, undercover purchases or other activities. The GCMS system confirms findings of cocaine, methamphetamine, LSD, other controlled and non-controlled substances, and volatile chemicals found at clandestine laboratories. Narcotic investigators need to know the confirmation of unknown drugs as quickly as possible in order to file cases in a timely manner with the Court system. Agilent Technologies is the sole ISO 9001-certified equipment manufacturer of the Crime Lab's six existing GCMS configured with options and proprietary software used by the Crime Lab. The Crime Lab seeks to purchase another Agilent Technologies GCMS in the amount of \$124,257.50, which is only available from Agilent Technologies. Attach screenshots and provide an explanation of any independent research you conducted, through internet searches, searching cooperatives, or discussions with others knowledgeable on the subject matter that corroborate that the item is available only from a single source. Crime Lab uses six Agilent Technologies GCMS that are compatible with the Crime Lab's other

Chemistry Unit equipment and standard operating procedures. One of the six is inoperable and this new purchase will replace it. The Crime Lab must maintain specific standards with all equipment in order to maintain American National Standards Institute (ANSI) National Accreditation Board (ANAB) accreditation as a forensic laboratory.
