A RESOLUTION DETERMINING THE NECESSITY FOR ACQUIRING REAL PROPERTY AND AUTHORIZING ITS APPROPRIATION OR CONDEMNATION FOR PUBLIC USE

WHEREAS, the Fort Worth City Council on February 27, 2024, in M&C _______, ordered and decreed that a public necessity existed to acquire 0.041 acres of land in right-of-way easement and .010 acres for a temporary construction easement from real property located at 5941 WJ Boaz Road in the Lake Crest Estates Addition, an Addition to the City of Fort Worth, Block E, Lots 2 and 3, Tarrant County, Texas, as described in the exhibits attached to the above-referenced M&C; those exhibits are incorporated herein for all purposes (the "Property");

WHEREAS, the Fort Worth City Council has determined that:

- the Property is needed for WJ Boaz Road Widening Improvements project (the "Project");
- the land rights in the Property are needed for roadway improvements including pavement reconstruction with curb and gutter, drainage improvements, street lights, shared use paths and reconstruction of the existing roundabout at Bowman Roberts Road;
- public necessity required the acquisition by condemnation of the Property, located within the alignment of the Project;
- the use of the Property will be a public use; and
- the Real Estate Division of the Property Management Department is authorized to acquire by negotiation the Property needed for the Project.

WHEREAS, negotiations between the City of Fort Worth and the property owner, Octavio Mesa, Jr., were unsuccessful due the inability to negotiate agreeable terms for the property interest being acquired by the City of Fort Worth; and
