SUBJECT

(CD 2, CD 3, CD 4, CD 5, CD 8, and CD 9) Authorize Execution of a Contract with Ragle, Inc., in the Amount of \$444,053.84 for 2021 Bridge Rehabilitation Contract 1 at Various Locations

RECOMMENDATION:

It is recommended that the City Council authorize execution of a contract with Ragle, Inc., in the amount of \$444,053.84 for 2021 Bridge Rehabilitation Contract 1 project (City Project No. 103098) at various locations.

DISCUSSION:

The purpose of this Mayor and Council Communication (M&C) is to authorize the execution of a contract with Ragle, Inc., in the amount of \$444,053.84 for the 2021 Bridge Rehabilitation Contract 1 project at twelve locations. The contract provides for the repair and rehabilitation of twelve bridges listed below:

Major bridge repair and rehabilitation includes structural repair; concrete and metal rail installation/repair; expansion joint replacement; metal beam guard fence repair; and guardrail end treatment replacement. Construction is expected to start in late Fall 2021 and be completed by Spring 2022. Upon completion of the project, there will be no anticipated impact on the general fund operating budget. The project was advertised for bid on June 17, 2021 and June 24, 2021 in the *Fort Worth Star-Telegram*. On July 22, 2021, the following bids were received:
