A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FORT WORTH, TEXAS, SETTING THE REGULARLY SCHEDULED CITY COUNCIL WORK SESSIONS AND CITY COUNCIL MEETINGS FOR JANUARY 2025 THROUGH DECEMBER 2025

WHEREAS, Chapter III, Section 5 of the Fort Worth City Charter requires the City Council to meet at such times and places as may be prescribed by ordinance or resolution and that not less than forty-four (44) regular and special meetings be held each calendar year; and

WHEREAS, in accordance with Section 3.2 of the City Council Rules of Procedure, unless otherwise officially changed by the City Council, the Council shall meet in the City Council Conference Room and Council Chamber respectively at the City Hall on Tuesday of each week at times set by the City Council by Resolution in order to be briefed on matters of interest to the city and conduct other city business; and

WHEREAS, it is the Council's general practice to hold Council Work Sessions and City Council meetings on alternating Tuesdays, with all meetings taking place at "Old" City Hall located at 200 Texas Street, until such time as the new Council chamber and work session room are completed at "New" City Hall, located at 100 Fort Worth Trail, after which such meetings will take place at "New" City Hall; and

WHEREAS, special events and occasions periodically get scheduled throughout the year at times that conflict with the Council's regular meeting times, and City Council finds it advisable to provide flexibility to adjust start times or location, as needed, without further City Council action, provided that agendas for meetings with alternate start times are properly noticed in accordance with state law; and

WHEREAS, adoption of this resolution serves as official action by the City Council in accordance with the City Charter setting the regular Work Session and City Council Meetings for January 2025 through December 2025.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT WORTH, TEXAS, THAT:
