AN ORDINANCE ADJUSTING APPROPRIATIONS IN THE GENERAL FUND, BY INCREASING APPROPRIATIONS IN THE CITY ATTORNEY, CITY SECRETARY, DEVELOPMENT SERVICES, ECONOMIC DEVELOPMENT, PARK AND RECREATION, FINANCIAL MANAGEMENT SERVICES AND TRANSPORTATION AND PUBLIC WORKS DEPARTMENTS IN THE TOTAL AMOUNT OF \$5,348,057.00 AND DECREASING APPROPRIATIONS IN NON-DEPARTMENTAL BY THE SAME AMOUNT; PROVIDING FOR A SEVERABILITY CLAUSE; MAKING THIS ORDINANCE CUMULATIVE OF PRIOR ORDINANCES; REPEALING ALL ORDINANCES IN CONFLICT HEREWITH; AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FORT WORTH, TEXAS:

SECTION 1.

That in addition to those amounts allocated to the various City departments for Fiscal Year 2020 -2021 in the Budget of the City Manager, there shall also be adjusted appropriations in the General Fund in the amount \$5,348,057.00, by increasing appropriations in the 1) City Attorney Department in the amount of \$233,774.00; 2) City Secretary Department in the amount of \$149,982.00; 3) Development Services Department in the amount of \$697,069.00; 4) Economic Development Department in the amount of \$3,217,130.00; 5) Financial Management Services Department in the amount of \$116,834.00 6) Park And Recreation Department in the amount of \$408,039.00; and 7) Transportation And Public Works Department in the amount of \$525,229.00, and decreasing appropriations in Non-Departmental in the General Fund by the same amount.

SECTION 2.

That should any portion, section or part of a section of this ordinance be declared invalid, inoperative or void for any reason by a court of competent jurisdiction, such decision, opinion or judgment shall in no way impair the remaining portions, sections, or parts of sections of this ordinance, which said remaining provisions shall be and remain in full force and effect.

SECTION 3.

That this ordinance shall be cumulative of Ordinance 24446-09-2020 and all other ordinances and appropriations amending the same except in those instances where the provisions of this ordinance are in direct conflict with such other ordinances and appropriations, in which instance said conflicting provisions of said prior ordinances and appropriations are hereby expressly repealed.
