(ALL) Repeal Appropriation Ordinance 26758-10-2023 and Adopt Appropriation Ordinance with Corrected Fund Name for the Previously Approved Federal Surface Transportation Block Grant Funds from North Central Texas Council of Governments for Eastside Arterial Broadband Improvements with No Change in Authorized Amount

RECOMMENDATION:

It is recommended that the City Council:

- 1. Repeal Appropriation Ordinance No. 26578-10-2023; and
- 2. Adopt the attached appropriation ordinance increasing estimated receipts and appropriations in the Grants Capital Projects Federal Fund, in the amount up to \$3,000,000.00, subject to receipt of the Grant, for the purpose of funding the Federal Surface Transportation Block Grant Funds from North Central Texas Council of Governments for Eastside Arterial Broadband Improvements (City Project No. 104934).

DISCUSSION:

The purpose of this Mayor and Council Communication (M&C) is to repeal, readopt, and appropriate ordinance 26578-10-2023 for the previously approved Federal Surface Transportation Block Grant Funds from North Central Texas Council of Governments for Eastside Arterial Broadband Improvements (City Project No. 104934) to correct the fund from Grants Capital Project Other Fund to Grants Cap Projects Federal Fund. The total amount of appropriated funds is an amount up to \$3,000,000.00.

On October 31, 2023, Mayor and Council approved M&C 23-0925 13RFP 22-0146 BROADBAND ENHANCEMENTS CH CITY authorizing the acceptance of \$3,000,000.00 in Federal Surface Transportation Block Grant funds from North Texas Council of Governments, and adopting the appropriation ordinance increasing estimated receipts and appropriations in the Grants Capital Project Other Fund in the amount of \$3,000,000.00, subject to the receipt of the grant.

Recommendation No. 6 errantly appropriated funding to the Grants Capital Project Other Fund rather than the Grants Cap Projects Federal Fund. This M&C will eliminate the original appropriation and appropriate funds correctly within the FY23 Broadband Project.

A Form 1295 is not required because: This M&C does not request approval of a contract with a business entity.
