SUBJECT

(CD 7 and CD 9) Authorize Execution of Amendment No. 2 in the Amount of \$75,469.00 to an Engineering Agreement with MAS Consultants, LLC for Water and Sanitary Sewer Replacement Contract 2020, WSM-D, Located in the Westside Alliance Area and Adopt Appropriation Ordinance, to Effect a Portion of Water’s Contribution to the Fiscal Years 2022-2026 Capital Improvement Programs

RECOMMENDATION:

It is recommended that the City Council:

1. Authorize execution of Amendment No. 2 in the amount of \$75,469.00, to City Secretary Contract No. 56208, an engineering agreement with MAS Consultants, LLC, for the Water and Sanitary Sewer Replacement Contract 2020, WSM-D project for a revised contract amount of \$383,339.00; and
2. Adopt the attached appropriation ordinance increasing estimated receipts and appropriations in the Water and Sewer Capital Projects Fund in the amount of \$75,469.00, transferred from available funds within the Water and Sewer Fund, for the purpose of funding the Water and Sanitary Sewer Replacement Contract 2020 WSM-D, project (City Project No. 103419) and to effect a portion of Water’s contribution to the Fiscal Years 2022-2026 Capital Improvement Program.

DISCUSSION:

On August 17th, 2020, Mayor and Council Communication (M&C) 21-0586, the City Council authorized an engineering agreement in the amount of \$269,495.00 with MAS Consultants, LLC (City Secretary Contract No. 56208) for the Water and Sanitary Sewer Replacement Contract 2020, WSM-D. This agreement was subsequently revised by Amendment Number 1 in the amount of \$38,375.00 administratively authorized on February 8th, 2022 that provided for additional design services on the project.

Amendment No. 2 will provide for the additional design and survey and design for the replacement of deteriorated water and sanitary sewer mains on the following street and easement located in the immediate vicinity of the project.

It is the practice of the Water Department to appropriate its CIP plan throughout the fiscal year, instead of within the annual budget ordinance, as projects commence, additional funding needs are identified, and to comply with bond covenants. The actions in the M&C will appropriate funds in support of the Water’s portion of the City of Fort Worth’s Fiscal Years 2022-2026 Capital Improvement Program, as follows:
