(CD 5 and CD 11) Authorize Execution of an Engineering Agreement with Neel Schaffer, Inc. in the Amount of \$658,400.00 for the Cast Iron Water Main and Sanitary Sewer Replacement in the Hampshire Boulevard Water and Sanitary Sewer Replacements Project and Adopt Appropriation Ordinance to Effect a Portion of Water's Contribution to Fiscal Years 2025-2029 Capital Improvement Program

RECOMMENDATION:

It is recommended that the City Council:

- 1. Authorize execution of an engineering agreement with Neel Schaffer, Inc., in the amount of \$658,400.00, for cast iron water main and sanitary sewer replacement on Hampshire Boulevard East of Beach Street; and
- 2. Adopt the attached Appropriation Ordinance increasing estimated receipts and appropriations in the Water and Sewer Capital Projects Fund in the amount of \$898,778.00, transferred from available PayGo funds within the Water and Sewer Fund, for the purpose of funding the Hampshire Boulevard Water and Sanitary Sewer Replacements project (City Project No.106068) to effect a portion of Water's Contribution to Fiscal Years 2025-2029 Capital Improvement Program.

DISCUSSION:

This Mayor and Council Communication (M&C) is to authorize execution of an engineering agreement with Neel Schaffer, Inc., in the amount of \$658,400.00 for the Hampshire Boulevard Water and Sanitary Sewer Replacements project for the preparation of plans and specifications for cast iron sanitary sewer and water main replacements on the following streets and easements:

In addition to the contract amount \$240,378.00 (Water: \$213,978.00; Sewer: \$26,400.00) is required for project management, real property acquisition, utility coordination, and material testing. This project will have no impact on the Water Department's operating budget when completed. The sewer component of the project is part of the Water Department's Sanitary Sewer Overflow Initiative Program.

It is the practice of the Water Department to appropriate its CIP plan throughout the Fiscal Year (FY), instead of within the annual budget ordinance, as projects commence, additional funding needs are identified, and to comply with bond covenants. The actions in the M&C will appropriate funds in support of the Water's portion of the City of Fort Worth's Fiscal Years 2025-2029 Capital Improvement Program.

Funding is budgeted in the Transfer to Water/Sewer account of the Water and Sewer operating budget for the purpose of funding the Hampshire Boulevard Water and Sanitary Sewer Replacements project within the Water & Sewer Capital Projects Fund.
