(CD 6) Authorize Acquisition of 1.846 Acres in a Right-of-Way Easement and 0.843 Acres of Temporary Construction Easements from Real Property Owned by Forestar (USA) Real Estate Group Inc. Located on W. Cleburne Road in the Moses Walters Survey, Abstract No. 1598, Tarrant County, Texas in the Amount of \$186,352.00 and Pay Closing Costs in an Amount Up to \$7,500.00 for a Total Cost of \$193,852.00 for the McCart Avenue/McPherson Boulevard Project (2014 Bond Program)

RECOMMENDATION:

It is recommended that the City Council:

- 1. Authorize acquisition of 1.846 acres in a right-of-way easement and 0.843 acres of temporary construction easements from real property owned by Forestar (USA) Real Estate Group Inc. located on W. Cleburne Road in the Moses Walters Survey, Abstract No. 1598, Tarrant County, Texas for the McCart Avenue/McPherson Boulevard Project (City Project No. C02505);
- 2. Find that the total purchase price of \$186,352.00 is just compensation and pay estimated closing costs in an amount up to \$7,500.00 for a total cost of \$193,852.00; and
- 3. Authorize the City Manager or his designee to accept the conveyances and record the appropriate instruments.

DISCUSSION:

The land rights in the subject property are needed for the McCart Avenue/McPherson Boulevard Project, a public purpose that provides for new travel lanes, intersection improvements, storm drainage improvements, sidewalks, and streetlights, as necessary.

An independent appraisal established the property's fair market value and the property owner has agreed to the negotiated amount of \$186,352.00 as total compensation for the needed property interest as shown below. The City will pay estimated closing costs in an amount up to \$7,500.00.

Upon City Council approval, staff will proceed with acquiring the needed right-of-way and temporary construction easement interests.
