UN9927, UN9912, UN9914, UN9926, UN9916, UN9913, UN9919, UN9911, UN9915, UN9917), FOR THE PURPOSE OF FUNDING CERTAIN IDENTIFIED PROJECTS (CITY PROJECT NO. C02505, 101014, 103270, 103271, 103272, 103278, 103280, 103281, 103299, 103300, 104154); PROVIDING FOR A SEVERABILITY CLAUSE; MAKING THIS ORDINANCE CUMULATIVE OF PRIOR ORDINANCES; REPEALING ALL ORDINANCES IN CONFLICT HEREWITH; AND PROVIDING AN EFFECTIVE DATE.

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FORT WORTH, TEXAS:

#### SECTION 1.

That in addition to those amounts allocated to the various City departments for Fiscal Year 2024-2025 in the Budget of the City Manager, there shall also be increased estimated receipts and appropriations in the Transportation Impact Fee Capital Fund in the cumulative amount of \$24,796,365.08, from available Transportation Impact fees and interest earnings collected, for the purpose of funding the certain identified projects (City Project No. C02505, 101014, 103270, 103271, 103272, 103278, 103280, 103281, 103299, 103300, 104154);
