Ordinance No._____

AN ORDINANCE INCREASING ESTIMATED RECEIPTS AND APPROPRIATIONS IN THE CRIME CONTROL AND PREVENTION DISTRICT CAPTIAL PROJECTS FUND IN THE AMOUNT OF \$6,139,967.00, TRANSFERRED FROM THE CRIME CONTROL, FOR THE PURPOSE OF FUNDING (1) \$99,000.00 FOR THE CRIME LAB STUDY (CITY PROJECT NO. P00032); (2) \$5,540,967.00 FOR THE RENOVATION OF EXISITNG SPACE FOR EXPANSION OF REAL TIME CRIME CENTER (CITY PROJECT NO. P00050); AND (3) \$500,000.00 FRO THE FAR NORTH PATROL SECTOR PILOT PROGRAM (CITY PROJECT NO. P00050); PROVIDING FOR A SEVERABILITY CLAUSE; MAKING THIS ORDINANCE CUMULATIVE OF PRIOR ORDINANCES; REPEALING ALL ORDINANCES IN CONFLICT HEREWITH; AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FORT WORTH, TEXAS:

SECTION 1.

That in addition to those amounts allocated to the various City departments for Fiscal Year 2024-2025 in the Budget of the City Manager, there shall also be increased estimated receipts and appropriations in The Crime Control And Prevention District Capital Projects Fund in the amount of \$6,139,967.00, transferred from the Crime Control and Prevention Fund, for the purpose of funding (1) \$99,000.00 for the crime lab study (city project number P00032); (2) \$5,540,967.00 for the renovation of existing space for Expansion of Real Time Crime Center (city project number P00050), and (3) \$500,000.00 for the Far North Patrol Sector Pilot Program (city project number P00050).

SECTION 2.

That should any portion, section or part of a section of this ordinance be declared invalid, inoperative or void for any reason by a court of competent jurisdiction, such decision, opinion or judgment shall in no way impair the remaining portions, sections, or parts of sections of this ordinance, which said remaining provisions shall be and remain in full force and effect.

SECTION 3.

That this ordinance shall be cumulative of Ordinance 27107-09-2024 and all other ordinances and appropriations amending the same except in those instances where the provisions of this ordinance are in direct conflict with such other ordinances and appropriations, in which instance said conflicting provisions of said prior ordinances and appropriations are hereby expressly repealed.

SECTION 4.

This ordinance shall take effect upon adoption.
