SUBJECT

(CD 2, CD 5, CD 7, CD 9 and CD 11) Authorize Execution of a Contract with Gibson & Associates, Inc., in the Amount of \$702,890.50 for the 2024 Bridge Rehabilitation Contract 1 at Various Bridge Locations

RECOMMENDATION:

It is recommended that the City Council authorize execution of a contract with Gibson & Associates, Inc., in the amount of \$702,890.50 for the 2024 Bridge Rehabilitation Contract 1 project at various bridge locations (City Project No.105238).

DISCUSSION:

In the Fiscal Year 2024 Pay-Go Contract Street Maintenance Program, bridge maintenance projects are grouped into specific contract packages. The recommended construction contract outlined in this Mayor and Council Communication (M&C) will provide rehabilitation for the 14 bridge locations listed below under the 2024 Bridge Rehab Contract 1 project (City Project No. 105238).

This project was advertised for bid on March 14 and March 21, 2024, in the *Fort Worth Star-Telegram*. On April 11, 2024, the following bids were received:

In addition to the contract amount, \$211,630.00 is required for project management, material testing, and inspection and \$105,434.00 is provided for project contingencies. Funding is budgeted in the General Capital Projects Fund for the Transportation and Public Works Department for the purpose of funding the 2024 Bridge Rehabilitation Contract 1 project.

Construction for this project is expected to start in Summer 2024 and be completed by early 2025. Upon completion of the project, there will be no anticipated impact on the General Fund operating budget.

M/WBE OFFICE – Gibson & Associates, Inc. is in compliance with the City's Business Equity Ordinance by committing to 16.36% MWBE

participation on this project. The City's MWBE goal on this project is 16%.

This project is located in COUNCIL DISTRICTS 2, 5, 7, 9 and 11

FISCAL INFORMATION / CERTIFICATION:
