## ACKNOWLEDGING MAYOR PARKER'S 2022 APPOINTMENTS TO THE BOARD OF COMMISSIONERS FOR THE HOUSING AUTHORITY OF THE CITY OF FORT WORTH, TEXAS

**WHEREAS**, the City Council of the City of Fort Worth established the Housing Authority of the City of Fort Worth, Texas, currently doing business as Fort Worth Housing Solutions ("FWHS"), on January 5, 1983, and

**WHEREAS**, FWHS is a housing authority created and operated in accordance with Chapter 392 of the Texas Local Government Code to provide decent, safe housing for low-to moderate-income residents, and

**WHEREAS**, Section 392.031 grants authority to the Mayor to appoint persons to serve as commissioners for FWHS; and

**WHEREAS**, the Board of Commissioners for FWHS is comprised of five (5) commissioners appointed to serve two-year terms, and

**WHEREAS**, Commissioner Danny Scarth passed away while in office, with his last board meeting being on November 18, 2021; and

**WHEREAS**, Dr. Carlos Walker has been selected to serve as a Commissioner of FWHS for the remainder of Mr. Scarth's term, which will end on January 31, 2023; and

**WHEREAS**, Brittany Hall, Terri Attaway, and Michael Ramirez are all current Commissioners of FWHS with terms set to expire on January 31, 2022; and

**WHEREAS**, Richard M. Stinson is a current Commissioners of FWHS with a term expiring in 2023; and

**WHEREAS**, Mayor Parker intends to appoint Dr. Carlos Walker to serve the remainder of Mr. Scarth's unexpired term and reappoint all current Commissioners with terms expiring in 2022 for new, two-year terms.

**NOW, THEREFORE, BE IT ACKNOWLEDGED BY THE CITY COUNCIL OF THE CITY OF FORT WORTH, TEXAS THAT MAYOR PARKER WILL MAKE THE FOLLOWING APPOINTMENTS TO THE BOARD OF COMMISSIONERS FOR THE HOUSING AUTHORITY OF THE CITY OF FORT WORTH, TEXAS:**

1. Dr. Carlos Walker for a term ending on January 31, 2023;
2. Brittany Hall for a term ending on January 31, 2024;
3. Terri Attaway for a term ending on January 31, 2024; and
4. Michael Ramirez for a term ending on January 31, 2024.
