SUBJECT

(CD 4 and CD 9) Authorize Execution of a Contract with Texas Materials Group, Inc., dba Texas Bit, in the Amount of \$1,707,683.14 for the 2021 North Riverside Drive Resurfacing Project

RECOMMENDATION:

It is recommended that the City Council authorize execution of a contract with Texas Materials Group, Inc., dba Texas Bit, in the amount of \$1,707,683.14 for the 2021 North Riverside Drive resurfacing project (City Project No. 102877) on approximately six lane miles of street segments.

DISCUSSION:

The Fiscal Year 2021 Pay-Go Contract Street Maintenance Program groups various types of street maintenance into specific contract packages. The recommended construction contract outlined in this Mayor and Council Communication (M&C) will provide street rehabilitation for approximately six lane miles of street segments of North Riverside Drive from 450 feet south of Clary Avenue to Northeast 28th Street. This contract includes pavement markings with new lane configurations and signage improvements (City Project No. 102877).

Construction for this project is expected to start in summer 2022 and be completed by winter 2022. Upon completion of the project, there will be no anticipated impact on the General Fund operating budget.

This project was advertised for bid on March 17, 2022, and March 24, 2022, in the *Fort Worth Star-Telegram*. On April 14, 2022, the following bids were received:

Funding is budgeted the the Transportation and Public Works Department's General Capital Projects Fund for the purpose of funding the 2021 HMAC 2 -N Riverside Dr project, as appropriated.

M/WBE OFFICE–Texas Materials Group complies with the City's Business Equity Ordinance by committing to 23% Business Equity participation in this project. The City's Business Equity goal for this project is 20%.

This project is located in COUNCIL DISTRICTS 4 and 9.
