

## PROPERTY DESCRIPTION

BEING a tract of land situated in the George Shields Survey, Abstract No. 1402, City of Fort Worth, Tarrant County, Texas, Being a part of Block 8, Edwards Heirs Addition. An Addition to the City of Fort Worth, according to the plat recorded in Volume 63, Page 2, Plat Records, Tarrant County, Texas, said tract of land bring more particularly described by metes and bounds as follows:

BEGINNING at a point in south right—of—way line of Pennsylvania Avenue (a variable width right—of—way), the northeast corner of Lot 4, said Block 8, Edwards Heirs Addition, the northwest corner of a 10' alley;

THENCE North 89°43'26" East, with the south right—of—way line of said Pennsylvania Avenue, a distance of 20.00 feet to a point for the northeast corner of said 20' alley, the northwest corner of Lot 1, said Block 8, Edwards Heirs Addition;

THENCE South 00°19'50" East, departing the south right-of-way line of said Pennsylvania Avenue, with the east line of said 20' alley, a distance of 195.00 feet to a point for the north end of a corner clip;

THENCE South 45°18'12" East, with said corner clip, a distance of 7.07 feet to a point for the south end of said corner clip, the north right—of—way line of Pruitt Street (a 50' width right—of—way), and the southwest corner of Lot 2R, Block 8, Edwards Heirs Addition, an Addition to the City of Fort Worth according to the plat recorded in County Clerk's Document Number D206020032, Plat Records, Tarrant County, Texas;

THENCE South 89°43'26" West, departing said corner clip, with the north right—of—way line of said Pruitt Street, a distance of 25.00 feet to a point for the southeast corer of Lot 3, said Block 8, Edwards Heirs Addition, the southwest corner of said 20' alley;

THENCE North 00<sup>1</sup>9'50" West, departing the north right-of-way line of said Pruitt Street, with the west line of said 20' alley, a distance of 200.00 feet to the POINT OF BEGINNING and containing a calculated area of 4,012 square feet or 0.092 acre of land.

NOTES: The basis of bearings for this Vacation is the Texas Coordinate System of 1983, North Central Zone, 4202, based upon GPS measurements, according to the GPS Reference Network.

A drawing of even date accompanies this metes and bounds description.
