With said curve to the right, through a central angle of 80°37'00", an arc length of 140.70 feet to a 5/8 inch iron rod found for the end of said curve to the right;

North 16°43'47" West, a distance of 133.68 feet to a point for the common corner of said Lot 1, Block A and Lot 3, Block A, of said North Glenwood (Vol. 388-64, Pg. 43), from which a 5/8 inch iron rod found bears South 84°26'55" West, a distance of 0.26 feet;

With said curve to the right, through a central angle of 248°03'39", an arc length of 216.47 feet to a point for a common corner of said Lot 3, Block A and Lot 2, Block A, of said North Glenwood (Vol. 388-41, Pg. 48), from which a 1/2 inch iron rod found bears South 27°55'39" East, a distance of 0.32 feet;

North 82°39'13" East, a distance of 79.70 feet to a 5/8 inch capped iron rod stamped "BHB INC" set for the southeast corner of said Lot 2, Block A, and at the intersection of the north right-of-way line of said Cobb Street and the west right-of-way line of said Riverside Drive;


