AN ORDINANCE INCREASING FISCAL YEAR 2025 ESTIMATED RECEIPTS AND APPROPRIATIONS IN THE EMS CAPITAL FUND IN THE TOTAL AMOUNT OF \$2,821,468.00, TRANSFERRED FROM THE EMERGENCY MEDICAL SERVICES OPERATING FUND, AND CONSISTING OF \$502,108.00 IN THE ANNUAL EMS VERF PROGRAMMABLE PROJECT (CITY PROJECT NO. P00154) FOR SUPPORT VEHICLE PURCHASES; AND (2) \$2,319,360.00 IN THE ANNUAL EMS AMBULANCE REPLACEMENT PROGRAMMABLE PROJECT (CITY PROJECT NO. P00153) FOR CHASSIS REMOUNTS AND PURCHASES OF AMBULANCES; MAKING THIS ORDINANCE CUMULATIVE OF PRIOR ORDINANCES; REPEALING ALL ORDINANCES IN CONFLICT HEREWITH; AND PROVIDING AN EFFECTIVE DATE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FORT WORTH, TEXAS:

SECTION 1.

That in addition to those amounts allocated to the various City departments for Fiscal Year 2024-2025 in the Budget of the City Manager, there shall also be an increase in the FY2025 estimated receipts and appropriations in the EMS Capital Fund in the total amount of \$2,821,468, transferred from the Emergency Medical Services operating fund, and consisting of (i) \$502,108.00 in the Annual EMS VERF programmable project (City Project No. P00154) for support vehicle purchases; and (ii) \$2,319,360.00 in the Annual EMS Ambulance Replacement programmable project (City Project No. P00153) for chassis remounts and purchases of ambulances.

SECTION 2.

That should any portion, section or part of a section of this ordinance be declared invalid, inoperative or void for any reason by a court of competent jurisdiction, such decision, opinion or judgment shall in no way impair the remaining portions, sections, or parts of sections of this ordinance, which said remaining provisions shall be and remain in full force and effect.

SECTION 3.

That this ordinance shall be cumulative of Ordinance 27107-09-2024 and all other ordinances and appropriations amending the same except in those instances where the provisions of this ordinance are in direct conflict with such other ordinances and appropriations, in which instance said conflicting provisions of said prior ordinances and appropriations are hereby expressly repealed.

SECTION 4.

This ordinance shall take effect upon adoption.
