AN ORDINANCE ADJUSTING ESTIMATED RECEIPTS AND APPROPRIATIONS IN THE STREET IMPROVEMENTS 2008 FUND, BY DECREASING ESTIMATED RECEIPTS AND APPROPRIATIONS IN THE FOLLOWING FORT WORTH PUBLIC ART PROJECTS: (1) BONNIE BRAE (CITY PROJECT NO. 100198) BY \$63,756.00, (2) PRAIRIE DOG PARK (CITY PROJECT NO. 101154) BY \$357,089.00; (3) MARINE CREEK PARKWAY (CITY PROJECT NO. 101158) BY \$511,067.95, (4) SUMMER CREEK ROUNDABOUT (CITY PROJECT NO. 102772) BY \$187,967.24, AND (5) OVERTON PARK PHASE 2 (CITY PROJECT NO. C02570) BY \$52,890.00 AND BY INCREASING ESTIMATED RECEIPTS AND APPROPRIATIONS IN THE CONCRETE REHABILITATION PROJECT (CITY PROJECT NO. 102884) BY THE SAME TOTAL AMOUNT OF \$1,172,770.19, PROVIDING FOR A SEVERABILITY CLAUSE; MAKING THIS ORDINANCE CUMULATIVE OF PRIOR ORDINANCES; REPEALING ALL ORDINANCES IN CONFLICT HERewith; AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FORT WORTH, TEXAS:

SECTION 1.

That in addition to those amounts allocated to the various City departments for Fiscal Year 2022-2023 in the Budget of the City Manager, there shall also be adjusted estimated receipts and appropriations in the Street Improvements 2008 Fund by decreasing estimated receipts and appropriations in the following Fort Worth Public Art projects (1) Bonnie Brae (City Project No. 100198) by \$63,756.00, (2) Prairie Dog Park (City Project No. 101154) by \$357,089.00, (3) Marine Creek Parkway (City Project No. 101158) by \$511,067.95, (4) Summer Creek Roundabout (City Project No. 102772) by \$187,967.24; and (5) Overton Park Phase 2, (City Project No. C02570), by \$52,890.00 and increasing estimated receipts and appropriations in the Concrete Rehabilitation project (City Project No. 102884) by the same total amount of \$1,172,770.19.

That this ordinance shall be cumulative of Ordinance 25773-09-2022 and all other ordinances and appropriations amending the same except in those instances where the provisions of this ordinance are in direct conflict with such other ordinances and appropriations, in which instance said conflicting provisions of said prior ordinances and appropriations are hereby expressly repealed.

SECTION 4.

This ordinance shall take effect upon adoption.
