## NOTICE OF PROPOSED STREET NAME CHANGE

### Existing Worth Creek Parkway to Tarleton State Parkway

The City of Fort Worth City Council will consider changing the name of Worth Creek Parkway to Tarleton State Parkway at the date and time indicated below:

Scheduled City Council Meeting on April 8, 2025 beginning at 6:00 p.m. in the City Council Chamber on the lobby level, 100 Fort Worth Trail.

If the change is adopted, the street name will be changed to Tarleton State Parkway, effective April 25, 2025.

A map exhibit is attached, showing the limits of the proposed street name change. This notice is intended to inform abutting property owners and other interested parties of the proposed street name change and scheduled meeting. You are invited to attend the City Council meeting and express an opinion relative to the proposed street name change on April 1, 2025 at 6:00 p.m.

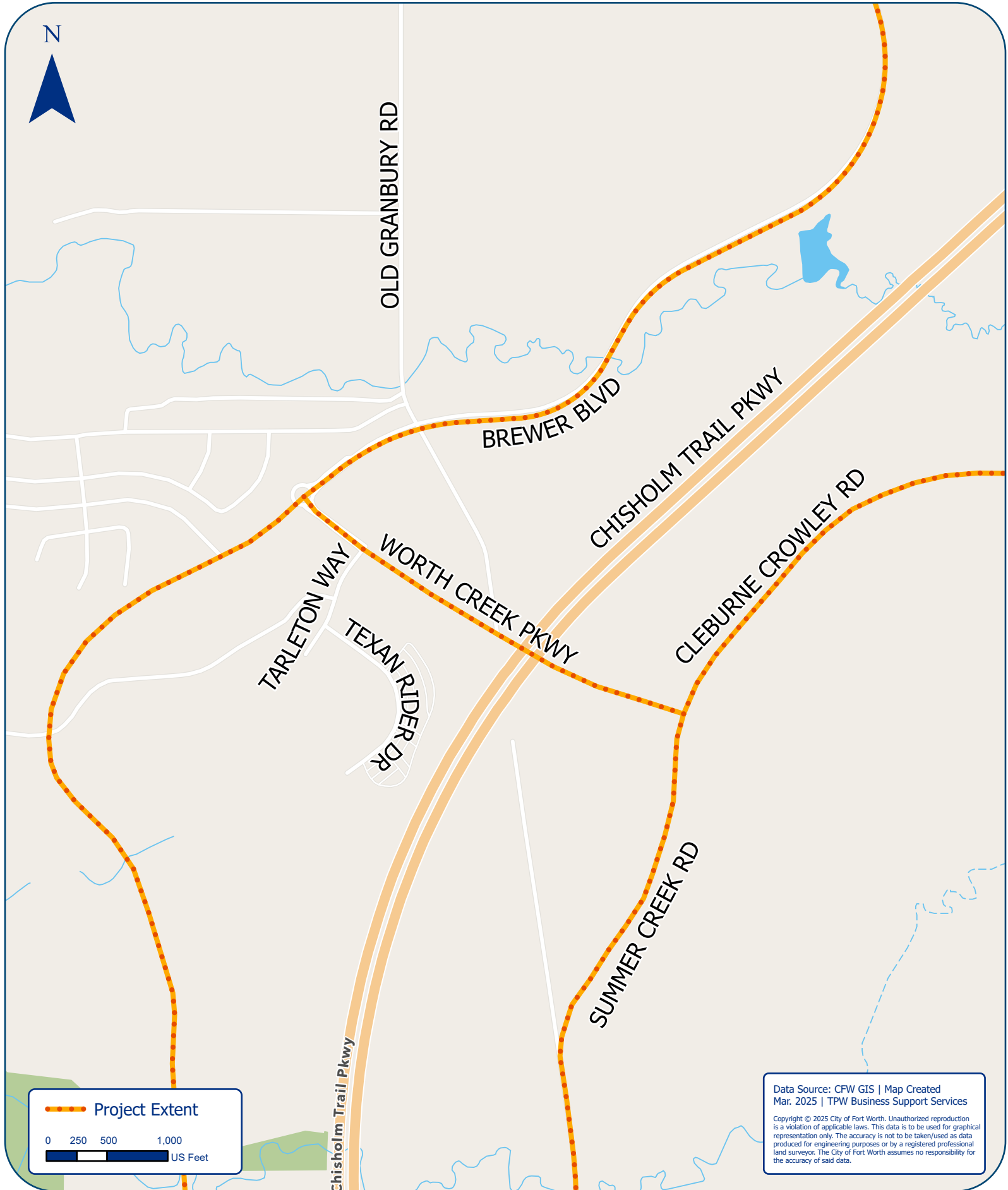
