AN ORDINANCE ADJUSTING ESTIMATED RECEIPTS AND APPROPRIATIONS IN THE GRANTS CAPITAL PROJECTS FEDERAL FUND, BY DECREASING ESTIMATED RECEIPTS AND APPROPRIATIONS IN A MULTIPLE OF PROJECTS IN A TOTAL AMOUNT OF \$318,698.60 AND INCREASING ESTIMATED RECEIPTS AND APPROPRIATIONS IN THE ARPA WRMC STALL PANEL REPLACE PROJECT (CITY PROJECT NO. 104397) BY THE SAME AMOUNT; PROVIDING FOR A SEVERABILITY CLAUSE; MAKING THIS ORDINANCE CUMULATIVE OF PRIOR ORDINANCES; REPEALING ALL ORDINANCES IN CONFLICT HEREWITH; AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FORT WORTH, TEXAS:

SECTION 1.

That the budget of the City of Fort Worth for Fiscal Year 2024-2025, as enacted by Ordinance 27107-09-2024, as amended, is hereby further amended to make the following adjustments to estimated receipts and appropriations in the Grants Capital Projects Federal Fund, by decreasing estimated receipts and appropriations in the following projects in a total amount of \$318,698.60 and decreasing estimated receipts and appropriations in the ARPA WRMC Stall Panel Replace project (City Project No. 104397) by the same amount.
