**RECOMMENDATION:**

It is recommended that the City Council:

1. Ratify acceptance of the awarded Fiscal Year 2026 Victims of Crime Act Grant from the Office of the Governor, Criminal Justice Division, in an amount up to \$176,300.00;
  2. Adopt the attached appropriation ordinance increasing estimated receipts and appropriations in the Grants Operating State Fund in an amount up to \$141,000.00 for the purpose of funding the Fiscal Year 2026 Victims of Crime Act Grant;
  3. Adopt the attached appropriation ordinance decreasing estimated receipts and appropriations in the Grants Operating Federal Fund in the amount of \$141,000.00 for the purpose of funding the Fiscal Year 2026 Victims of Crime Act Grant;
  4. Adopt the attached appropriation ordinance increasing estimated receipts and appropriations in the Grants Operating State Fund in an amount up to \$35,300.00 for grant match, as a transfer from the Crime Control Prevention District that is included in the Fiscal Year 2026 budget for the purpose of funding the Fiscal Year 2026 Victims of Crime Act Grant; and
  5. Adopt the attached appropriation ordinance decreasing estimated receipts and appropriations in the Grants Operating Federal Fund in the amount of \$35,300.00 for grant match, as a transfer from the Crime Control Prevention District that is included in the Fiscal Year 2026 budget for the purpose of funding the Fiscal Year 2026 Victims of Crime Act Grant.

**DISCUSSION:**

The Council has previously approved the grant application in Mayor and Council Communication (M&C) 25-0174. At the time of M&C submission, the grant was federally funded. When the grant was awarded, the Office of the Governor (OOG), Criminal Justice Division, changed this to a state funded award in an amount up to \$141,000.00 with an amount up to \$35,300.00 match requirement for a total amount up to \$176,300.00. This M&C is requesting ratification of all appropriations from Grants Operating Federal Fund to Grants Operating State Fund.

Indirect costs are allowed and will be accepted at the current rate of 3.51%. This is a reimbursement grant. The Grant Application Tracking Number is GRNT-APPL-0000000112.
