RECOMMENDATION:

It is recommended that the City Council:

- 1. Amend Mayor and Council Communication 21-0053, authorizing execution of a Community Facilities Agreement with West River Homes Building, LLC to increase City participation to \$313,156.00 for the South Oak Grove sewer replacement project; and
- 2. Adopt the attached appropriation ordinance adjusting estimated receipts and appropriations in the Water & Sewer Revenue Bonds Series 2021 Fund, in the amount of \$146,420.00, by decreasing the estimated receipts and appropriations in the Unspecified project (City Project No. UNSPEC) and increasing estimated receipts and appropriations in the Community Facilities Agreement Bucket (City Project No. P00001) by the same amount, for the purpose of funding the South Oak Grove Replacement project (City Project No. 102739).

DISCUSSION:

On January 12, 2021, Mayor and Council Communication (M&C 21-0053), the City Council authorized the execution of a Community Facilities Agreement (CFA) with West River Homes LLC., with City participation in the amount of \$166,736.00 for the South Oak Grove Estates sewer replacement project and appropriated funds for the project. The developer initially chose to privately bid the project. The developer has now decided to publicly bid the project due to state law limits for City participation in privately bid developer projects. The Water Department is seeking additional funding for the increased cost share in the amount of \$146,420.00 based on the signed bid proposal from the contractor who was awarded the public bid.
