AN ORDINANCE ADJUSTING FISCAL YEAR 2019-2020 RECEIPTS AND APPROPRIATIONS IN THE ROCK CREEK SPECIAL ASSESSMENT CAPITAL PROJECT FUND BY A TOTAL OF \$54,518 TO REALLOCATE A PORTION OF THE SAVINGS FROM THE WATER RELATED MAJOR IMPROVEMENTS PROJECT TO OFFSET OVERRUNS IN COSTS FOR THE COMPLETED PORTION OF THE SANITARY SEWER RELATED IMPROVEMENTS PROJECT; PROVIDING FOR A SEVERABILITY CLAUSE; MAKING THIS ORDINANCE CUMULATIVE OF PRIOR ORDINANCES; REPEALING ALL ORDINANCES IN CONFLICT HERewith; AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FORT WORTH, TEXAS:

SECTION 1.

That the budget of the City of Fort Worth for Fiscal Year 2019-2020, as enacted by Ordinance 23835-09-2019, as amended, is hereby further amended as follows: (i) decrease the Water Related Major Improvements Project (City Project No. 101174) by \$52,973.00, (ii) increase the Sanitary Sewer Related Improvements Project (City Project No. 101175) by the same amount; (iii) decrease the University Water Improvements Project (City Project No. 101177) by \$1,545.00; and (iv) increase the University Sanitary Sewer Improvements Project (City Project No. 101179) by the same amount.

SECTION 2.

That should any portion, section or part of a section of this ordinance be declared invalid, inoperative or void for any reason by a court of competent jurisdiction, such decision, opinion or judgment shall in no way impair the remaining portions, sections, or parts of sections of this ordinance, which said remaining provisions shall be and remain in full force and effect.

SECTION 3.

That this ordinance shall be cumulative of Ordinance No. 23835-09-2019 and all other ordinances and appropriations amending the same except in those instances where the provisions of this ordinance are in direct conflict with such other ordinances and appropriations, in which instance said conflicting provisions of said prior ordinances and appropriations are hereby expressly repealed.

SECTION 4.

This shall take effect on adoption and amend the Fiscal Year 2020 budget.
