A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FORT WORTH, TEXAS, ADDING CITY COUNCIL WORK SESSIONS ON FOR BUDGET RELATED PRESENTATIONS AND A CITY COUNCIL MEETING TO VOTE ON THE BUDGET AND RELATED ITEMS IN AUGUST AND SEPTEMBER 2023

WHEREAS, in accordance with Section 3.2 of the City Council Rules of Procedure, unless otherwise officially changed by the City Council, the Council shall meet in the City Council Conference Room and Council Chamber respectively at the City Hall on Tuesday of each week at times set by the City Council by Resolution in order to be briefed on matters of interest to the city and conduct other city business;

WHEREAS, the City Manager's presentation of the City's operating and capital budgets ("Budget"), Budget Work Sessions, and the City's Council's vote on the Budget and related items will be held in additional City Council Work Sessions and an additional City Council Meeting to the regularly scheduled meetings listed in Resolution 22-2554;

WHEREAS, special events and occasions periodically get scheduled throughout the year at times that conflict with the Council's regular meeting times, and City Council finds it advisable to provide flexibility to adjust start times, as needed, without further City Council action, provided that agendas for meetings with alternate start times are properly noticed in accordance with state law; and

WHEREAS, adoption of this resolution serves as official action by the City Council in accordance with the City Charter setting City Council Work Session and a City Council Meeting for budget related items in August and September 2023.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT WORTH, TEXAS, THAT:

- 1. The City Council will hold a City Council Work Session for the City Manager to present the Budget on August 8, 2023. This Work Session will likely start at 10:00 a.m. but may start at such other time as reflected in the posted agenda for such meeting, which agenda shall be published in advance in accordance with state law.
- 2. The City Council will hold City Council Work Sessions on the Budget during August and September 2023 as follows:
 - a. August 10, 2023;
 - b. August 15, 2023, if necessary;
 - c. August 24, 2023, if necessary;
 - d. August 25, 2023, if necessary;

- e. September 7, 2023, if necessary; and
- f. September 8, 2023, if necessary

These Work Sessions will likely start at 8:30 a.m. but may start at such other time as reflected in the posted agenda for such meeting, which agenda shall be published in advance in accordance with state law.

- 3. The City Council will hold a City Council Meeting on September 19, 2023 to vote on the City's Budget, ad valorem tax rate, and other related items. This City Council Meeting will likely start at 11:00 a.m. but may start at such other time as reflected in the posted agenda for such meeting, which agenda shall be published in advance in accordance with state law.
- 4. A calendar indicating the above dates and times is attached to this Resolution as Exhibit A.
- 5. The City Council Work Sessions and City Council Meeting referred to in this Resolution shall be held at City Hall unless otherwise changed by Ordinance or Resolution.
