(CD 8, CD 9 and CD 11) Adopt Appropriation Ordinance in the Amount of \$100,000.00 for Increased Project Costs for the Sanitary Sewer Rehabilitation, Contract 118 Project and to Effect a Portion of Water's Contribution to the Fiscal Years 2024-2028 Capital Improvement Program

RECOMMENDATION:

It is recommended that the City Council adopt the attached appropriation ordinance increasing estimated receipts and appropriations in the Water and Sewer Capital Projects Fund in the amount of \$100,000.00, transferred from available funds within the Water and Sewer Fund, for the purpose of funding the Sanitary Sewer Rehabilitation, Contract 118 project (City Project No. 102789) and to effect a portion of Water's contribution to the Fiscal Years 2024-2028 Capital Improvement Program.

DISCUSSION:

On August 03, 2021, Mayor and Council Communication (M&C) 21-0538, the City Council authorized an engineering agreement in the amount of \$302,590.50 with Arredondo, Zepeda & Brunz, LLC, (City Secretary Contract No. 56320) and an additional \$234,814.50 for related expenses for a project total of \$537,405.00 for the Sanitary Sewer Rehabilitation, Contract 118 project.

The additional appropriations in this M&C will provide for additional real property acquisition for the remaining sanitary sewer easements that are necessary on the project.

It is the practice of the Water Department to appropriate its CIP plan throughout the Fiscal Year, instead of within the annual budget ordinance, as projects commence, additional funding needs are identified, and to comply with bond covenants. The actions in the M&C will appropriate funds in support of the Water's portion of the City of Fort Worth's Fiscal Years 2024-2028 Capital Improvement Program, as follows:
