**SUBJECT**

(CD 3, CD 4, CD 8, and CD 9) Authorize Execution of a Contract with MW Panel Tech LLC, in the Amount of \$969,857.20 for 2022 Bridge Rehabilitation at Six Locations

**RECOMMENDATION:**

It is recommended that the City Council authorize execution of a contract with MW Panel Tech LLC, in the amount of \$969,857.20 for the 2022 Bridge Rehabilitation Contract 1 project (City Project No.103454) at six locations.

**DISCUSSION:**

The purpose of this Mayor and Council Communication (M&C) is to authorize execution of a contract with MW Panel Tech LLC, in the amount of \$969,857.20 for 2022 Bridge Rehabilitation Contract 1 project at six locations. The contract provides for the repair and rehabilitation of six bridges listed below:

Major bridge repair and rehabilitation includes structural repair; sealant application on bridge arches; concrete and metal rail installation/repair; bridge approach slab replacement; expansion joint replacement; metal beam guard fence repair, and guard rail end treatment replacement. Construction is expected to start in late winter 2022 and be completed by summer 2023. Upon completion of the project, there will be no anticipated impact on the general fund operating budget. The project was advertised for bid on September 8, 2022 and September 15, 2022 in the *Fort Worth Star-Telegram*. On October 6, 2022, the following bids were received:

Funding is budgeted in the TPW Dept Highway & Streets Department's General Capital Projects Fund for the purpose of funding the 2022 Bridge Rehab Contract 1, as appropriated.

M/WBE OFFICE—M W Panel Tech LLC is in compliance with the City's Business Equity Ordinance by committing to 22% MWBE participation on this project. The City's MWBE goal on this project is 13%.
