A RESOLUTION AUTHORIZING EXECUTION OF AN ADVANCE FUNDING AGREEMENT (AFA) BETWEEN THE STATE OF TEXAS, ACTING BY AND THROUGH TEXAS DEPARTMENT OF TRANSPORTATION, AND THE CITY OF FORT WORTH IN THE ESTIMATED AMOUNT OF \$973,909.00, WITH CITY PARTICIPATION ESTIMATED TO BE \$124,253.00, FOR IMPROVEMENTS TO TRAFFIC SIGNALS ON TRINITY BOULEVARD FROM GREENBELT ROAD TO AMON CARTER BOULEVARD HIGHWAY SAFETY IMPROVEMENT PROJECT

WHEREAS, federal law establishes federally funded programs for transportation improvements to implement its public purposes, and

WHEREAS, the Texas Transportation Code, Section 201.103 establishes that the State shall design, construct and operate a system of highways in cooperation with local governments, and Section 222.052 authorizes the Texas Transportation Commission to accept contributions from political subdivisions for development and construction of public roads and the state highway system within the political subdivision, and

WHEREAS, federal and state laws require local governments to meet certain contract standards relating to the management and administration of State and federal funds, and

WHEREAS, the Texas Transportation Commission has codified 43 TAC, Rules 15.50-15.56 that describe federal, state, and local responsibilities for cost participation in highway improvement and other transportation projects, and

WHEREAS, the Texas Transportation Commission passed Minute Orders Numbered 116292 and 116073 authorizing the State to undertake and complete a highway improvement or other transportation project generally described as Off System Signal System Upgrades; and

WHEREAS, the City of Fort Worth identified the need to improve existing traffic signals, install flashing yellow arrows and detection upgrades at 14 traffic signals along Trinity Boulevard from Greenbelt Road to Amon Carter Boulevard; and

WHEREAS, the City of Fort Worth and Texas Department of Transportation have negotiated terms in the amount of \$973,909.00, with federal participation in the amount of \$808,121.00, state participation in the amount of \$41,535.00 and local participation in the estimated amount of \$124,253.00, for engineering and construction of signals improvements on Trinity Boulevard .

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT WORTH, TEXAS, THAT:

The City Manager is hereby authorized to execute an Advance Funding Agreement (CSJ: 0902-90-238) with the Texas Department of Transportation in the amount of \$973,909.00, with federal participation in the amount of \$808,121.00, state participation in the amount of \$41,535.00 and local participation in the estimated amount of \$124,253.00, for engineering and construction of signals improvements on Trinity Boulevard from Greenbelt Road to Amon Carter Boulevard. All cost overruns will be the responsibility of the City of Fort Worth.
