THENCE southerly along the arc, a distance of 96.19 feet to a point to a point of reverse curve to the left having a radius of 870.44 feet and a central angle of 08°03'53";

THENCE northerly, 34.44 feet along a non tangent curve to the right, having a radius of 227.48 feet, a central angle of 08°40'28" and a chord bearing N09°54'55"W, 34.41 feet to a point;

THENCE N43°59'08"E, a distance of 9.76 feet to a point at the most northerly nortwest corner of said Lot 1;




