## RIGHT-OF-WAY EASEMENT

BEING a tract of land out of the Bramlett and Ryan Survey, Abstract Number 227, in the City of Haslet, Tarrant County, Texas and being a portion of a tract of land described in deed to Daniel Lewis Nance, as recorded under Document Number 206231643 (hereinafter referred to as "Nance Tract") of the Official Public Records of Tarrant County, Texas (O.P.R.T.C.T.) and being more particularly described as follows:

BEGINNING at a $1 / 2$ inch iron rod found with yellow cap stamped "STEADHAM RPLS 4281" for the southeast corner of said Nance Tract, having grid coordinates of N: 7,037,329.208 |E: 2,315,650.247;

THENCE South 89 degrees 33 minutes 38 seconds West, with south line of said Nance Tract a distance of 543.11 feet to a $1 / 2$ inch iron rod found for the southwest corner thereof;

THENCE North 00 degrees 26 minutes 22 seconds West, with the west line of said Nance Tract, a distance of 35.60 feet to a $5 / 8$ inch iron rod with red plastic cap stamped "CRIADO" set (hereinafter referred to as "capped iron rod set") in the west line thereof;

THENCE North 89 degrees 42 minutes 15 seconds East, over and across said Nance Tract, a distance of 491.02 feet to a capped iron rod set at the beginning of a tangent curve to the left, having a radius of 535.00 feet, with a delta angle of 05 degrees 35 minutes 14 seconds, whose chord bears North 86 degrees 54 minutes 38 seconds East, a distance of 52.15 feet;

THENCE Along said tangent curve to the left, continuing over and across said Nance Tract, an arc length of 52.17 feet to a capped iron rod set in the east line thereof;

THENCE South 00 degrees 26 minutes 22 seconds East, with the east line of said Nance Tract, a distance of 36.78 feet to the POINT OF BEGINNING, and containing 0.437 acres $(19,041$ square feet) of land, more or less.

Note: Surveyed on the ground September 2021. Map of Survey of even date attached herewith. Bearings are based on Global Positioning Satellite (GPS) System observations using Western Data Systems Virtual Reference System (WDS VRS). Horizontal data is on the North American Datum of 1983 (NAD ‘83) (2011). Coordinates are on the Texas State Plane Coordinate System, North Central Zone (4202) with all distances adjusted to surface by a project combined scale factor of 1.00012.

Note: Unless otherwise noted, all corners are monumented with a $5 / 8$-inch iron rod with a red cap stamped "Criado".
