SUBJECT: CONDUCT SECOND PUBLIC HEARING FOR PROPOSED CITY-INITIATED FULL-PURPOSE ANNEXATION OF APPROXIMATELY 9.079 ACRES OF THE DALE EARNHARDT WAY AND RIGHT-OF-WAY (AX-24-006) IN DENTON COUNTY, LOCATED NORTH OF HIGHWAY 114 AND WEST OF INTERSTATE HIGHWAY 35 WEST, IN THE FAR NORTH PLANNING SECTOR (FUTURE COUNCIL DISTRICT 10)

The September 17th City Council agenda will contain an ordinance to approve the annexation of approximately 9.079 acres of the Dale Earnhardt Way and right-of-way, in the Far North Planning Sector. The site is situated within the extraterritorial jurisdiction of the City of Fort Worth and is located north of Highway 114 and west of Interstate Highway 35 West. The site will continue to be used as a road. Attached is an exhibit for reference.

The annexation policy states that the City will annex any road and right-of-way that is adjacent to and provides access to property within the City. In addition, there are adjacent properties that have been previously annexed into the City that have developed as commercial type uses. The development of the area has resulted in increased traffic along Dale Earnhardt Way, and it is critical the street be maintained to City of Fort Worth standards. This section of Dale Earnhardt Way and right-of-way meets this criterion.

Many of the adjacent properties are already within Fort Worth City Limits and the surrounding area is currently experiencing urban development. Staff has determined that the City is able to provide municipal services upon annexation in accordance with State law, without negatively impacting service provision within the city. Annexation of this site is thus consistent with the City's annexation policy.

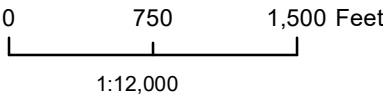
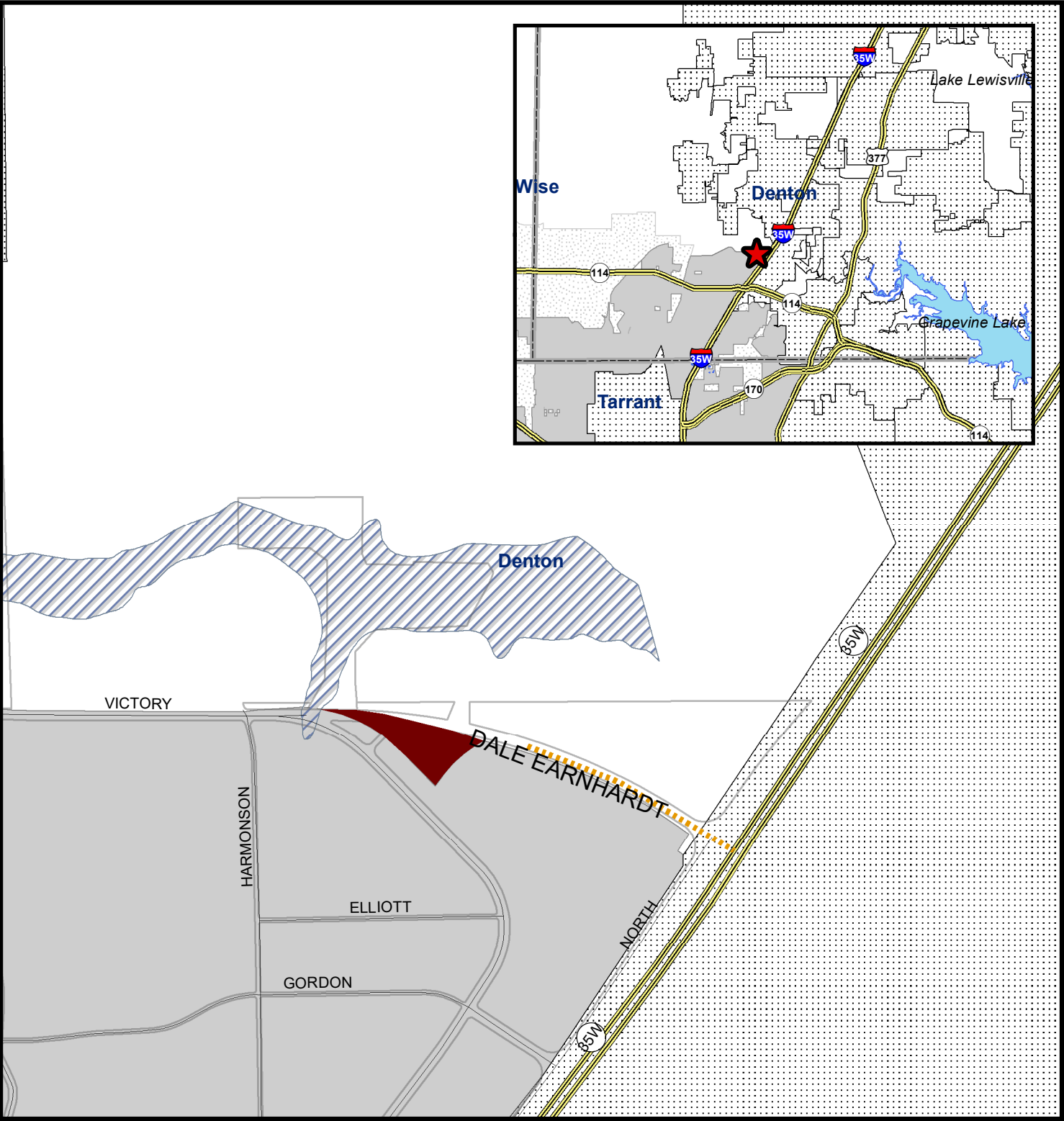

A first public hearing was held during the August 13th City Council meeting. The approval of annexation of this area is anticipated to occur on September 17, 2024.

The annexation, if adopted, will be an addition to Council District 10.
