Emerson Power and Water Solutions components used as a part of an Ovation system are designed specifically to operate with the other standard components selected for the Ovation architecture, including Dell workstations and servers. Components selected to be part of Ovation are vigorously tested and validated as a complete and integrated system. The use of non-standard platforms or non-tested models/configurations is not recommended due to the following main reasons:

- The use of non-validated or tested equipment may introduce abnormal operation or unexpected failures to the system. Putting at risk the Ovation Network and the processes operated/controlled by the DCS.
- The Microsoft Operating Systems chosen for use on Ovation have been customized and are part of a corporate agreement between Emerson and DELL/Microsoft and can only be purchased by means of the existing agreement and installed in equipment as part of the agreement.

- Equipment procured via third parties will not be covered by Emerson warranties or component coverages as part of SureService. If customer provided equipment is suspected to be at fault, Emerson will require the customer to address resolution of that product and may request that as part of the diagnostics that standard equipment is used to prove functionality.
- Potential failures due to abnormal operation induced by non-tested equipment or configurations may potentially result in disruption to the control system and Emerson's ability to pinpoint the issue may be limited and only consultative in nature.
- CISCO products hardware, firmware and its configuration prepared and validated for use with Ovation DCS are a critical part of the control system and are subject to internal quality and validation procedures. The goal of validation is to verify that any given component (as defined above) will not have negative impact on system stability, availability and reliability when connected with other elements of the Ovation DCS. All validation procedures are prepared and run by Research and Development Department of Emerson Process Management Power & Water Solutions.
