## A RESOLUTION DETERMINING THE NECESSITY FOR ACQUIRING REAL PROPERTY AND AUTHORIZING ITS APPROPRIATION OR CONDEMNATION FOR PUBLIC USE

WHEREAS, the Fort Worth City Council on February , 2021, in M& C \_\_\_\_\_\_, ordered and decreed that a public necessity existed for 1.076 acres in permanent sewer easement and 2.247 acres for temporary construction easement from improved property located at 7000 East Rosedale Street, south of East Rosedale Street and north of Lake Arlington, in Lot 3R, Tract 3 Lake Arlington Industrial Park, City of Fort Worth, Tarrant County, Texas, in the exhibits attached to the above-referenced M&C; those exhibits are incorporated herein for all purposes (the "Property");

## WHEREAS, the Fort Worth City Council has determined that:

- the Property is needed for the Lake Arlington Force Main and Lift Station Project (the "Project")
- the land rights in the Property are needed for new sewer improvements as necessary;
- public necessity required the acquisition by condemnation of the Property, located within the alignment of the Project;
- the use of the Property will be a public use; and the Real Property Division of the Property Management Department is authorized to acquire by negotiation the Property needed for the Project.

The property is located at 7000 East Rosedale Street, south of the East Rosedale Street and north of Lake Arlington, in the Lake Arlington Industrial Park, Lot 3R, Tract 3, City of Fort Worth, Tarrant County, Texas.
