AN ORDINANCE VACATING AND EXTINGUISHING A PORTION OF E. 14TH STREET, A SIXTY-FOOT WIDE RIGHT-OF-WAY SITUATED BETWEEN JONES STREET, A SIXTY-FOOT WIDE RIGHT-OF-WAY, AND CALHOUN STREET, A SIXTY-FOOT WIDE RIGHT-OF-WAY, IN JOHN CHILDRESS SURVEY, ABSTRACT NO. 250, CITY OF FORT WORTH, TARRANT COUNTY, TEXAS, AS DEDICATED BY AN UNRECORDED PLAT OF DAGGETT'S ADDITION, AN ADDITION TO THE CITY OF FORT WORTH, TEXAS, AND CONTAINING APPROXIMATELY 12,000 SQUARE FEET OR 0.275 ACRES OF LAND MORE OR LESS; PROVIDING FOR VACATION OF THE EASEMENTS IN THE LAND AND REVERSION TO THE ADJACENT PROPERTY OWNER; PROVIDING THAT THE CITY SHALL RETAIN ALL EXISTING UTILITY EASEMENTS; REPEALING ALL ORDINANCES IN CONFLICT HEREWITH; AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FORT WORTH,
TEXAS:

SECTION 1.

That a portion of E. 14th Street, a sixty-foot wide right-of-way, situated between Jones Street, a sixty-foot wide right-of-way, and Calhoun Street, a sixty-foot wide right-of-way, in John Childress Survey, Abstract No. 250, City of Fort Worth, Tarrant County, Texas, as dedicated by an unrecorded plat of Daggett's Addition, an addition to the City of Fort Worth, Texas, and containing approximately 12,000 square feet or 0.275 acres of land more or less, as more specifically described in Exhibit "A" attached hereto and incorporated herein by reference, be and the same is vacated and extinguished.

SECTION 2.

That easements to the land in the above-described vacated street right-of-way are hereby released and shall revert to the adjacent owner as provided by law.
