SUBJECT

(ALL) Authorize Execution of a Contract with Westhill Construction Inc., in the Amount of \$1,189,797.00 for 2020 Concrete Restoration Contract 4 at Various Locations

RECOMMENDATION:

It is recommended that the City Council authorize execution of a contract with Westhill Construction Inc., in the amount of \$1,189,797.00 for 2020 Concrete Restoration Contract 4 project (City Project No. 102696) at various locations.

DISCUSSION:

In the Fiscal Year 2020 Pay-Go Contract Street Maintenance Program, various types of street maintenance are grouped into specific contract packages. The 2020 Concrete Restoration Contract 4 provides for the repair and reconstruction of failed concrete pavement at twenty eight locations listed on the street list attachment (City Project No. 102696). Construction for this project is expected to start in early 2021 and to be completed by summer 2021. Upon completion of the project there will be no anticipated impact on the General Fund operating budget.

This project was advertised for bid on July 23, 2020, and July 30, 2020, in the *Fort Worth Star-Telegram*. On August 27, 2020, the following bids were received:
